# **NHS Supply Chain Operating Model**


The new NHS Supply Chain was designed to help the NHS deliver clinically assured, quality products at the best value, through a range of specialist buying functions. Its aim is to leverage the buying power of the NHS to negotiate the best deals from suppliers and deliver savings of £2.4 billion back into NHS frontline services by the end of the financial year 2022 / 2023.

The model consists of 11 specialist buying functions, known as **Category Towers**, delivering:

- medical consumables
- capital medical equipment
- non-medical products (such as food and office solutions).

Three **enabling services** underpin the model:

- logistics
- supporting technology infrastructure
- · transactional services.

## **Medical IT Framework and What We Offer**



#### **Framework Overview**

#### The **Medical IT Framework**

- Runs from 1 February 2021 for a period of 2 years (with an option to extend for 2 years)
- Offers the NHS a fully OJEU compliant route to purchase for both Digital Solutions and supporting infrastructure solutions, either through a Direct Award (Call off) or a full/partial pricing exercise with awarded suppliers.
- Enables the NHS to specify and create fully bespoke clinical IT solutions across single or multiple departments, sites and trusts.
- The framework team offers a high level of project support and template documentation to support with a clear market test process.





### **Dedicated Support**

- The Medical IT team will support alongside our customer facing team and work closely with you
- We ensure all the procurement activities are performed in line with planned procurement timelines
- We can also sit on consortium boards while the procurement exercise is being carried out, if required.

#### **Documentation Suite**

- A full suite of template documentation OBS templates and configurable contract documentation, process plan, implementation timelines and evaluation templates - to support you through each stage of the procurement process
- Support from pre-market engagement through to contract award.













### Framework Conditions of Award



When applying for award on the Framework, suppliers are asked to complete our Grounds for Exclusion document. Further details of the Grounds for Exclusion are available on request.

The following documents, along with a signed Framework Agreement, are required from suppliers before they are able to place a contract via the Framework:

- ISO9001:2015 accredited by the United Kingdom
   Accreditation Service (or equivalent) to cover all segments of the Applicant's and the product's supply chain. This should include, but not be limited to, manufacturing, storage and distribution.
- Employer's (Compulsory) Liability Insurance = £5,000,000
- Public Liability Insurance = £5,000,000
- Product Liability Insurance = £5,000,000











## Framework Award Criteria (for all products)



#### 2. Criteria applicable across all product lines

2.1 Standards and Legislation

#### STANDARD AND LEGISLATION

#### Medical Devices Directive 93/42/EEC (as amended)

All products must have their CE marking evident on the product and/or packaging.

Or

**Medical Devices Regulation 2017/745** (as amended)

All products must have their CE marking evident on the product and/or packaging.

- 2.2. Where applicable all Applicants must meet the DSP Toolkit Standards as set out by NHS Digital.
- 2.3. Applicants must provide NHS Supply Chain with Safety Data Sheets (SDS) for all products that fall under REACH (Registration, Evaluation, Authorisation and restriction of Chemicals) 2007 more specifically, an SDS must be provided if a substance or a mixture supplied is classified as hazardous under the CLP Regulation (EC) No 1272/2008.
- 2.4. If a product line contains phthalates this must be indicated on the packaging of that product line in accordance with Directive 2007/47/EC (amending Directives 90/385/EEC and 93/42/EEC).
- 2.5. Electrical product lines must comply with the requirements of the Directive on waste electrical and electronic equipment (WEEE Directive 2012/19/EU) and the Directive on the restriction of the use of certain hazardous substances in electrical and electronic equipment (RoHS 2 Directive 2011/65/EU).
- 2.6. All product lines and packaging should be latex free where possible. If a product line or any packaging contains or does not contain latex this must be labelled on the product line or packaging (as applicable) to inform the user.
- 2.7. During the term of the Framework Agreement Applicants must make NHS Supply Chain aware of any awarded product line that is classed by the MHRA as a Medicinal Product.
- 2.8. All product lines must be delivered free of charge to a location as directed by either NHS Supply Chain or the customer


